Bonney needs to prepare for future growth such as restaurants and convenience stores. The county is concerned about Bonney that it will be a financial burden to the county as well as the quality of the development. County would like to see at least 80 foot lots like the Pecan Grove subdivision, as well as Maple View.

The county commissioners would like to see a city plan in regard to future revenue and growth. They would like to see the property taxes start before the developments come.

Although the county does not have the legal authority to a approve the ETJ swap with Alvin, Alvin would like the blessing of the commissioner's court. No official action needs to be taken by the county. There can be a Letter of No Objection from the county.

The Village of Bonney City Service Plan can be presented to the commissioner's court on May 10<sup>th</sup>, 2022, meeting or after the regular meeting. It could be a workshop. Not an executive session, but a special workshop.
