

CITY OF BONNEY ORDINANCE NO. 3-80

AN ORDINANCE ESTABLISHING COMPREHENSIVE RULES AND REGULATIONS FOR TRAFFIC IN THE TOWN OF BONNEY, TEXAS; PROVIDING FOR THE ENFORCEMENT AND OBEDIENCE OF SUCH TRAFFIC REGULATIONS AND ESTABLISHING THE LIMITATIONS OF WEIGHT THAT CAN BE CARRIED BY TRUCKS AND/OR VEHICLES ON THE STREETS AND ALLEYS AND COUNTY ROADS; IN THE TOWN OF BONNEY, TEXAS; REPEALING ANY AND ALL ORDINANCES IN CONFLICT HEREWITH; CONTAINING A SEVERABILITY CLAUSE; AND PROVIDING FOR THE PUBLICATION OF THIS CAPTION AND THE EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, the town of BONNEY, TEXAS, has determined that, in order to insure the general health, safety and welfare of all the residents of the town of Bonney, a comprehensive traffic ordinance, regulating traffic upon the public streets of the town of Bonney, should be passed, and also including a limitation of the weights that should be carried in trucks and/or other vehicles in the town of Bonney, Texas.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE TOWN OF BONNEY, TEXAS, THAT:

WHEREAS, it is hereby found and determined by the Town Counsel of the town of Bonney, Texas, that the public highways, and streets under the jurisdiction of the town of Bonney are insufficient to carry the maximum gross vehicle loads authorized by Article 6701D-12 Vernons Civil Statutes, is amended.

1. THAT, vehicles used exclusive for the hauling of concrete gravel or other such substances, shall not be operated upon the public highways and streets within the town of Bonney, Texas, with the axel load to exceed thirty thousand (30,000) gross pounds. And it shall be unlawful to operate any truck or any other vehicle on the public streets of the town of Bonney, Texas, that shall exceed said load limit of thirty thousand (30,000) gross pounds.

2. There is hereby established certian areas where trucks may not be operated i.e. on County Road 51, and County Road number 618, and


the City Counsel is hereby authorized to post a notice saying NO THRU TRUCKS PERMITTED, and NO THRU TRUCKS MAY BE USED ON SAID HIGHWAYS TO DISCHARGE ANY LOAD AND GO THRU TRAFFIC TO THE TERMINATION OF THE OUTSKIRTS OF THE CITY BONNEY, TEXAS.

3. Any person violating the terms of this ordinance shall be fined an amount of not less than fifty dollars (\$50.00), not more than two hundred dollars (\$200.00).


4. The City Marshal of the Town of Bonney, Texas, shall have the authority to enforce all things under this act.

This ordinance shall take effect from and after its passage, adoption and publication of its caption in one issue of The Angleton Times Newspaper.
