NOTICE TO CONTRACTORS: All contractors working in the City are required to register at www.bonneytexas.gov. Copies of Licenses, Insurance & Bond Information associated with this permit must be on file with the Village of Bonney. This permit becomes null and void if construction or work authorized is not commenced within six [6] months of permit date, or if construction is suspended for a period of one [1] year at any time after work is commenced.

If the permit application is approved, a Pre-Construction Meeting and a minimum 48-hours' notice is required prior to the start of construction. Additional permits may be required depending on the type of work being performed.
